Alperia confirms its presence in the Hydroelectric sector with the acquisition of Hydrodata S.p.A.

South Tyrol's green energy multi-utility takes control of Hydrodata, a wellknown consulting engineer with more than 40 years of national and international market experience as consulting engineer in the hydro and environmental engineering sector. This way, Alperia further consolidates its investment in its own consulting engineering capabilities and plans to create a Innovation Lab in Bolzano for Hydroelectric and Water 4.0 projects.

8 October 2020 – today, Alperia has successfully completed the acquisition of 50,5% of the shares of Hydrodata S.p.A to Alperia S.p.A. Hydrodata S.p.A, located in Torino, Piemonte, is one of the leading Italian consulting engineers, having more than 40 years of multidisciplinary international and national market experience, especially in the hydro and environmental sector. With over 3,400 projects in its pipeline so far, and a total turnover of over €4.4 million, and over 37 FTEs, Hydrodata's engineering experience together with Alperia Group's technical expertise in the renewable, power, and district heating sector, will create strong synergies, and allow to broaden activities on the services market, as well as to push research with the creation, in Bolzano, of a hub for innovation in the Hydroelectric and integrated water management sector.

The acquisition of the 50.5% of the equity of Hydrodata S.p.A, for a total consideration of \in 2.2 million of investment, is based on the evaluation of \in 7.1 million (100%) of its *Enterprise Value*.

As at 31 December 2019 Hydrodata S.p.A. recorded revenues of over \in 4.4 million, an EBITDA of \in 0.4 million. As at 30 June 2020 Hydrodata S.p.A. recorded half-yearly revenues of over \in 2.1 million, an EBITDA for the period of approximately \in 0.3 million.
